**Diesel prices now falling, petrol steady**  
**New Delhi,**  
The auto fuel seems to have switched sides over revision in rates with diesel prices now beginning to fall while petrol holding steady.  
The oil marketing companies (OMCs) on Saturday reduced the pump price of diesel across the country, the second such downward revision this week.  
In the national capital, diesel prices have fallen by 13 paise per litre on Saturday, bringing down the transport fuel price to Rs 73.27 a litre. The price of diesel also fell on Thursday by 16 paise per litre.  
While diesel prices have fallen, OMCs have kept the petrol prices steady.  
The fuel prices have remained at the same level so far this month. But petrol prices have been rising regularly since August 16, when it stood at Rs 80.57 a litre in Delhi. The price of fuel may remain steady or fall in coming days as global crude prices have shown some indication of softening over expectation of a prolonged demand squeeze over Covid-19 disruptions.

**Automobile scrappage policy in final stages: Gadkari**  
**New Delhi,**  
Union Minister Nitin Gadkari on Saturday said the Centre is close to finalise the ambitious automobile scrappage policy. Gadkari spoke at the 60th ACMA Annual Session which was held virtually.  
In connection with the scrappage policy, he informed the session that the scheme is expected to receive Centre's approval in a month's time or even earlier. The policy is expected to encourage customers to go in for new purchases which will be backed-up by government incentives in lieu of their old vehicles.  
Significantly, the move is considered to be the most vital element of any further package to prop up the sector's growth.  
Besides, he urged the auto component sector to increase exports and strive for quality manufacturing. He said that government is now of a mindset to increase the country's exports and limit imports by imposing duty. On the infra push, he said that Centre will build 22 'Green Expressway Projects' and work on some have already started. In addition, he called upon the industry to set up clusters for automobile manufacturing next to the upcoming expressways.

**Facebook tests feature to auto-share Instagram Stories**  
**San Francisco,**  
Facebook is reportedly testing a new feature that gives users the option to view Instagram Stories from within Facebook, thereby removing the need to manually crosspost.  
To see Instagram Stories on Facebook as part of the test, people will have to link their two accounts.  
Only people who follow you on Instagram will be able see your Stories on Facebook.  
The change was first spotted by @ec\_wife on Twitter, according to a report in The Next Web (TNW) on Friday. Facebook later confirmed the test to social media consultant Matt Navarra. The social media network said that the feature will not transgress user privacy as Instagram users can choose not to have their Stories visible on Facebook. Facebook CEO Mark Zuckerberg last year announced plans to integrate the messaging services of the company's family of apps. For example, Instagram and Facebook Messenger recently began merging their chat functionalities. It is expected that WhatsApp will also eventually be part of the integration. As part of the latest efforts to make it easier to share Instagram Stories, the platform is allowing users who are part of the test to know where the post was first shared.

**Microsoft's \$10bn JEDI contract win reaffirmed, Amazon to protest**  
**San Francisco,**  
Amazon has vowed to continue its protests after the US Department of Defense (DoD) has reaffirmed that Microsoft has won the \$10 billion Joint Enterprise Defense Infrastructure, or JEDI, Cloud computing contract.  
"The Department has completed its comprehensive re-evaluation of the JEDI Cloud proposals and determined that Microsoft's proposal continues to represent the best value to the government," the DoD said in a statement on Friday.  
Amazon's Cloud computing arm, called Amazon Web Services (AWS), said in a blog post that the DoD's re-evaluation is "nothing more than an attempt to validate a flawed, biased, and politically corrupted decision." After Microsoft was awarded the decade-long contract in October last year, AWS filed a bid protest directly to DoD, challenging the decision. "Taking corrective action should have provided the DoD an opportunity to address the numerous material evaluation errors outlined in our protest, ensure a fair and level playing field, and ultimately, expedite the conclusion of litigation," AWS said in a blog post on Friday. "Unfortunately, the DoD rejected that opportunity," AWS alleged.
