

Vijaya Diagnostic IPO to open next week: Price band Rs. 522-531

Ahmedabad, Healthcare chain Vijaya Diagnostic Centre's IPO will open for subscription next week on Wednesday, September 1 and the three-day public issue will conclude on September 3. The company has fixed the IPO fixed price band Rs. 522-531 per share.

The initial public offer (IPO) is entirely an offer for sale (OFS) of 35,688,064 equity shares by the promoters, Dr S Surendranath Reddy and investors Karakoram Ltd and Kedaara Capital Alternative Investment Fund - Kedaara Capital AIF 1. The initial share-sale will see stake dilution of 35% by promoter and existing shareholders.

As per market observers, Vijaya Diagnostics grey market premium (GMP) is in the range of Rs. 35-40. The grey market is an unofficial platform, wherein trading starts after the announcement of



the IPO price band till the listing of the shares.

"The company's 96% of revenue comes from Hyderabad. It has reported a good set of numbers in FY2021.. We have seen in Krsnaa Diagnostics Ltd IPO that the IPO has been priced at the higher end of the peers and after the listing, the company is trading below the issue price. We have a neutral view on Vijaya Diagnostic Center IPO," said Yash Gupta, Equity Research Analyst, Angel Broking.

Vijaya Diagnostic Centre plans to raise around Rs.

1,895 crore, on the upper band price. The shares of the company are likely to list on the stock exchanges on September 14.

Govt to launch special incentive scheme to support 75 startups

New Delhi, The government will soon launch a special incentive scheme to support 75 startups in the areas of telemedicine, digital health and artificial intelligence (AI) to coincide with the 'Azadi Ka Amrit Mahotsav' being celebrated from August 15 onwards.

The scheme will be launched by the Biotechnology Industry Research Assistance Council (BIRAC), a public sector enterprise under the Department of Biotechnology, government of India, a release said on Wednesday.

Union Minister of State for Science and Technology, Jitendra Singh, said that instructions to this effect have been conveyed to the members of BIRAC led by its chairperson Renu Swarup.

Swarup is also the Secretary in Department of Biotechnology (DBT) under the Ministry of Science and Technology. Interacting with the board of directors of

BIRAC, the minister said the grand challenge to identify the top 75 innovations is the most appropriate task in the 75th year of India's Independence that will promote R&D in the health sector at a time when humanity the world over is dealing with the challenges posed by the Covid-19 pandemic.

BIRAC has been promoting and supporting new ventures under the Startup India and Make in India programmes in the areas of biotechnology ecosystem growth. "The BIRAC has lent funding support of over Rs 2,128 crore to more than 1,500 startups, enterprises and SMEs. From supporting less than 50 biotechnology startups in 2012 with innovative funding of less than Rs 10 crore, the BIRAC is now funding over 5,000 such startups with over Rs 2,500 crore funding. By 2024, BIRAC targets to support more than 10,000 biotechnology startups," the release said.

Strong buffers to help Indian banks withstand asset risks

New Delhi, India's second coronavirus wave is increasing asset risks for banks, but the country's economic recovery, a tightening of loan underwriting criteria, and continued government support will prevent a sharp spike in problem loans, according to a Moody's Investors Service report. "A severe deterioration of banks' asset quality is unlikely, despite an expected rise in new loan impairments, particularly among individuals and small businesses that were hit hardest by the virus outbreak. This is because government initiatives like the emergency credit linked guarantee scheme (ECLGS).

Tech firms promise Biden billions of dollars to bolster cybersecurity

San Francisco, Tech giants like Apple, Google, Microsoft and Amazon have promised US President Joe Biden to help him improve cybersecurity infrastructure in the wake of several high-profile hacking cases against government agencies and energy infrastructure. The meeting at the White House on Wednesday was attended by Alphabet and Google CEO Sundar Pichai, Amazon CEO Andy Jassy, Apple CEO Tim Cook, Microsoft Chairman and CEO Satya Nadella and IBM Chair and CEO Arvind Krishna, along with representatives from other industries. The tech honchos made Biden familiar with how they are addressing the

growing cyber threats.

"The reality is, most of our critical infrastructure is owned and operated by the private sector, and the federal government can't meet this challenge alone," Biden told the tech firms.

Apple announced that it would work with its suppliers to "drive mass adoption of multi-factor authentication" as well as providing new security trainings, incident response, and vulnerability remediation, reports The Verge. Google said it would spend more than \$10 billion over the next five years to strengthen US cybersecurity and the software supply chain. Microsoft said it would invest \$20 billion in the next five years, while Amazon planned to offer a multi-factor authentication device to all Amazon Web Services (AWS) account holders for free. The cybersecurity meeting

comes in the wake of several incidents like the massive Solarwinds hack, the Kaseya ransomware attack and the Colonial Pipeline shutdown resulting from a cyber-attack. Alarmed at repeated cyber-attacks on the country, Biden in May signed an executive order, implementing new policies to improve national cybersecurity.

"Protecting our nation from malicious cyber actors requires the federal government to partner with the private sector."

Petrol, diesel prices remain static on Wednesday

New Delhi, After price cuts, petrol and diesel prices in the country remained unchanged on Wednesday as oil marketing companies decided to go on pause mode to see global developments in the oil markets before any further revision.

Accordingly, in the national capital, petrol continues to be sold for Rs 101.49 per litre and diesel for Rs 88.92 a litre. Across the country as well fuel prices remained unchanged on Wednesday.

Global crude oil prices have fallen on past few days but has again priced up over \$70 a barrel now. With more barrels set to enter the markets next month and demand conditions remain fluctuating, there may be downward pressure on crude again.

The pump prices of auto fuels were static since July 18. The long price pause for auto fuels came after fuel prices increased for 41 days in the current financial year. The 41 increases have taken up petrol prices by Rs 11.44 per litre in Delhi. Similarly, diesel rates have increased by Rs 8.74 per litre in the national capital.-IANS

Auto industry witnessing comparatively slower growth: RC Bhargava

New Delhi, High taxation as well as state government's road levy have driven passenger vehicle cost and dented sales, Maruti Suzuki India Chairman R.C. Bhargava said while speaking at the 61st SIAM Annual Convention here on Wednesday.

Bhargava said that more and more people are now finding it difficult to afford cars due to their high costs. "The people in this country have great aspiration for vehicles. But the industry has been witnessing comparatively slower growth for the last 18 months. The government and the industry need to take necessary action collectively to revive the sector," Bhargava said.

Equity market in green after opening flat

Mumbai, The Indian stock market traded on a positive note on Thursday morning with the BSE Sensex gaining over 100 points. The market rose after a flat opening on the back of gains in the index-heavy-weight Reliance Industries. At around 10.05 a.m., Sensex was trading at 56,065.82, higher by 121.61 points or 0.22 per cent from its previous close of 55,944.21 points. It opened at 55,988.41 and has so far touched an intra-day high of 56,068.73 points or a low of 55,854.07 points.

The Nifty50 on the National Stock Exchange was trading at 16,673.55, higher by 38.90 points or 0.23 per cent from its previous close. Manish Hathiramani, technical analyst with Deen Dayal Investments said: "We are successfully trading above 16,600 which is an indication of strength. 16,800-16,850 is a potential target and a resistance zone too." Traders should look at this level to take profits from their positions and update stops. Intra-day falls can be used to accumulate long positions.
